SUMMARY OF MEMBERSHIP STATUS & DUES FOR 2022

Membership in MAPA shall be open to legal assistants, paralegals and students in paralegal programs who live or work within one hundred miles of Dane County, Wisconsin; attorneys; paralegal educators; and others interested in promoting the profession.

Active \$85 Active Members must be at least 18 years of age, live or work in Dane County, Wisconsin, and meet one of the state qualifications:

- Any individual who has successfully completed the Certified Legal Assistant (CLA) examination of NALA and is employed as a paralegal/legal assistant as attested to by their attorney/employer.
- Any individual who has completed a formal course of study for paralegals/legal assistants and has submitted satisfactory evidence thereof and whose attorney-employer attests that such person is qualified as a paralegal/legal assistant.
- 3. Any individual who has a minimum of three years of law-related experience under the supervision of an attorney including at least one year of in-house training as a paralegal/legal assistant, whose attorney-employer attests that such person is qualified as a paralegal/legal assistant.

Active membership, as listed above, working for a government agency.

Student	\$30	Student members must be at least 18 years old and currently enrolled in a formal course of study for paralegals/legal assistants.
Associate	\$45	Associate members must be at least 18 years old and interested in supporting the paralegal/legal assistant profession and do not otherwise qualify for Active or Student membership.
Sustaining	\$75	Sustaining members are those individuals, law firms, corporations and paralegal/legal assistant program representatives who endorse the paralegal/legal assistant concept or are involved in the promotion of the paralegal/legal assistant profession who contribute dues.

Active members may retain Active status though not employed as set forth above, provided they have been active members of MAPA for at least one year and shall continue to pay dues. Said members shall retain all the privileges of Active membership, except the right to hold office as an officer or director.
